## Part I: Good Will and the Will to do Good

## Part II: Investigation Questions

- (1) What does it mean to have good will towards others?
- (2) The winter months are often associated with a season of good will and giving. Should we think of good will as having a "season" and, if so, what does the seasonal quality of holiday good will mean for the rest of the year?
- (3) What is the relationship between peace on earth and good will?
- (4) When you give a donation for the benefit or gift you receive in return, such as a t-shirt, free parking, or better tickets to a sports game, does the thing you receive change whether or not your gift was charitable?
- (5) Is good will towards others a kind of altruism? Is altruism always at odds with self-interest? Why or why not?
- (6) What do you think of Goodwill's mission statement (above)? Does it seem to align with Kant's or Luke's vision of the good will? What do dignity and the quality of life of individuals have to do with good will?
- (7) Is Goodwill's mission a good model for the religious and moral idea of good will? Are there other individuals or organizations that embody good will?
- (8) Does good will around the holidays mean being charitable? If so, should we be more charitable at other times of year?



## Part III: More questions on good will and what the right thing is to do:

(9) Can being charitable to others become patronizing in a hurtful way? If so, when? What's the different
(10) Would a person of good will ever lie? If so, under what conditions? If not, why not?
(11) If you try to do the right thing but fail, have you still done a good thing?
a. Imagine trying to help someone out of an automobile accident, and in the process that person g hurt more than if only paramedics had helped. Have you still done a good thing in this case?
b. Next, imagine trying to help save a drowning child who dies despite your efforts to save her or he Have you still done a good thing in trying to help?
(12) Do people today have good will toward those with whom they disagree politically? Should they? Why why not, to each question?
(13) Think of a President or other public figure with whom you have disagreed intensely. Did you, do you would you have good will toward that person? Should you have? If so, why? If not, why not?
(14) When some people are caught doing something wrong, they admit that they knew what they were do was wrong. Why do some people feel motivated to do the right thing and others not? Does every sometimes do the wrong thing?
